EQUIPMENT:

Equipment and systems covered by this certificate are as follows:

The light fitting consists of one or two flameproof enclosures. Each enclosure consists mainly of an aluminium alloy compartment (including a built-in electronic ballast and terminals) and glass tube containing the light source (fluorescent lamp). It can be single or dual , and pole, ceiling or pendant mounted.
